#### 13.1 Clean up Lake Simcoe

Resolution: C-2023-236

WHEREAS in 2009 the Government of Ontario released its Lake Simcoe Protection Plan, which called for Lake Simcoe's phosphorus pollution to be reduced by 50% to 44 tonnes per year to protect our cold-water fishery and to prevent excessive weed growth and algae blooms; and WHEREAS the Government of Ontario has still not funded or implemented a plan to reduce Lake Simcoe's phosphorus pollution to 44 tonnes per year; and

WHEREAS Lake Simcoe's phosphorus pollution has risen by 26% between 2015 and 2020 relative to its 2009 level.

BE IT THEREFORE RESOLVED THAT the Council of the Township of Brock requests the Government of Ontario to fund and implement a plan to reduce Lake Simcoe's phosphorus pollution to 44 tonnes per year with a target date of 2030; and

THAT a copy of this resolution be sent to the Honorable Andrea Khanjin, Minister of the Environment, Conservation and Parks; and all Lake Simcoe watershed MPPS and municipalities.
