

## **The Corporation of the Township of Brock**

### **By-law Number 3252-2024**

#### **Being a By-law to appoint Municipal By-Law Enforcement Officers, Property Standards Officers and Provincial Offences Officers for the Corporation of the Township of Brock**

---

**Whereas** Section 11 of the Municipal Act 2001, S.O. 2001, c.25 provides a municipality the authority to pass by-laws for any service or thing that the municipality considers necessary or desirable for the public; and

**Whereas** Section 227 of the Municipal Act, 2001, S.O. 2001 c.25 authorizes council to appoint such officers and employees as may be necessary for the implementation of Council's decisions including the enforcement of municipal by-laws;

**Whereas** pursuant to Section 15.1 of the Ontario Building Code Act, S.O. 1992, c.23, the Council of the Corporation of the Township of Brock has adopted By-law 1562-98-PP, being a Property Standards By-law (the Property Standards By-law"); and

**Whereas** section 15 of the Police Services Act, R.S.O. 1990, c.P.15 authorizes Councils to appoint Municipal Law Enforcement Officers as Peace Officers for the purpose of enforcing municipal by-laws;

**Whereas** pursuant to Section 11 of the Municipal Act 2001 S.O. 2011, c25, The Council of the Corporation of the Township of Brock has adopted By-law 957-88-PP, as amended being a by-law to govern vehicular traffic in the Township of Brock and;

**Whereas** the Council of the Corporation of the Township of Brock deems it necessary to appoint Property Standards Officers for the purpose of administering and enforcing the Property Standards By-law; and

**Whereas** the Council of the Corporation of the Township of Brock deems it necessary to appoint Municipal Law Enforcement Officers to administer and enforce the Parking By-law, other by-laws of the Corporation of the Township of Brock and any Act of Legislation.

**Now Therefore** the Council of the Corporation of the Township of Brock enacts as follows:

1. That By-laws 1818-2003-AP, 2249-2009-AP, 2580-2015-PP, 2208-2009-PP, 2604-2015-PS, 2714-2017-PP, 2878-2019-PS, 2958-2020, 2977-2020, 3126-2022, 3129-2022, 3143-2022, 3189-2023, and 3227-2023 be repealed in their entirety.
2. That Sarah Jones, Lisa Jarrett, Kim McConkey, Holly Eade, James Ridgway, Kristen Smith, Jacob English, Amanda Ranger, Jason Lapp, Chris Robinson, Luke Puckrin, and Rick Harrison are hereby appointed as Municipal By-Law Enforcement Officers and Provincial Offences Officers for the Corporation of

the Township of Brock for the purpose of enforcing the By-laws of the Corporation of the Township of Brock.

- 3. That Sarah Jones, Lisa Jarrett, Kim McConkey, Holly Eade, James Ridgway, Kristen Smith, Jacob English, Amanda Ranger, Chris Robinson and Luke Puckrin are hereby appointed as Property Standards Officers for the purpose of enforcing the Township of Brock Property Standards By-laws and any related By-law or legislation.
- 4. That this by-law shall come into force and effect on the date it is enacted by the Council of the Corporation of the Township of Brock.
