COW-2023-005 16-Jan-23 BE IT RESOLVED THAT Report No. 2023-FI-001 titled "Capital Projects Status Report – December 2022" be received; and,

THAT the projects as identified in Appendix A to Report No. 2023-FI-001, be approved for closure and any surplus funds be transferred to the original funding source; and,

THAT the Sunderland Town Hall Rose Window reflect \$150,000 in Schedule A; and

THAT \$20,064 be transferred from Reserves and Reserve Funds to the projects identified under section 3 a) of this report as follows:

\$14,276 from Capital Reserve Fund – Fleet

\$5,788 from Capital Reserve Fund – Public Buildings

THAT \$3,000 be transferred from the Manilla Hall Reserve Fund to the Manilla Hall Outdoor LED Sign project; and

THAT a Capital Reserve Fund – Parks be established for the purpose of Park related capital requirements; and

\$64,185 to a new Capital Reserve Fund – Parks

\$133,461 to Capital Reserve Fund – Roads
