Hi Tim,

The meetings included concept drawings for the arena project.

The funding that we have in place restricts the possibilities for the expansion project.

The two areas where there is flexibility is the size of the ice and the number of dressing rooms.

The ice surface must be expanded to a minimum 75' x 175' and to a maximum of 80' x 200'. The current size is 70' x 170' for reference.

The dressing rooms must be a minimum of 4 and a maximum of 6, with 2 dressing rooms being fully accessible.

We are looking for feedback from the user groups on what would be their priority if we cannot complete the full scope of the project. This along with a brief explanation of the reasoning for the choice is being requested should it be required.

I hope this is helpful and that you are able to provide some feedback.
