About the FCM annual conference-

I had the pleasure of attending the Federation of Canadian Municipalities (FCM) 2024 Conference. This was the first time I have attended the FCM conference. The conference was an extremely valuable information and learning experience which saw over 1,000 municipal elected officials and staff from all over Canada attend. I attended many sessions throughout the four-day period. As always, I find that the networking is of utmost importance. Whether it is talking to Ministers, Mayors, other council members or senior staff, I learned so much of how business is done throughout the province, at the municipal level and are all issues that are front and center in Brock. Again, it is very rare to have the access to so much knowledge in one room. The main priority of the FCM is advocating higher levels of government for a new funding model. Educationally, I will highlight some of the key sessions I attended and some important conversations I had throughout the two days.

Overview of some of the many sessions I attended and key learnings-

Shifting to resilient, net-zero communities: Leveraging the Green Municipal Fund

Explore the remarkable transformations across the country as communities—big and small—progress towards equitable, resilient and net-zero futures. Discover the factors that make a project successful, valuable lessons learned and how communities are advancing solutions to achieve environmental, social and economic goals. Learn how the Green Municipal Fund's financing, funding and capacity-building solutions can assist your community in turning sustainability goals into reality.

Redefining our Future: The urgent need for a Municipal Growth Framework

Amid rapid national population growth and increased challenges— specifically in housing and infrastructure—municipalities need innovative solutions to address local needs essential for the well-being of all Canadians. FCM is advocating for a new Municipal Growth Framework to help achieve federal housing targets and ensure communities have the necessary infrastructure and services.
