1.0 Issue / Origin

The Supervisor of By-Law and Animal Services is responsible for preparing and presenting quarterly reports.

2.0 Background

Council has requested in each quarter a report on the activities of the By-Law and Animal Services Department, including the Township of Brock Dench Animal Shelter. This report represents the second quarter report (Q2) from April 1st, 2024 to June 30th, 2024. The statistics for the quarterly reports include, but not limited to, emails, phone calls, and tracking software and programs used by the Department, FirePro (Bylaw) and Shelter Buddy (Animal Shelter).

3.0 Analysis

In the second quarter of 2024 the Township of Brock By-Law and Animal Services Department responded to incidents/investigations in both by-law and animal services. The most significant change is in animal services in which the department saw a significant decrease in service calls for sick and injured wildlife, especially raccoons. The Township thankfully did not experience any calls regarding bird flu and as such the calls in Q2 were at the normal average levels for wildlife emergencies.

In both Q1 and Q2, the animal shelter continued finding homes for dogs and cats and experienced a very low intake for cats and kittens which in the spring is rare as traditionally, the population of cats and kittens would be very high. In Q2, the animal shelter also saw a decrease in the number of dogs found abandoned, stray and a low number of reports of dog bites or interference calls. Staff patrolling the parks reported the number of owners in non-compliance of the animal control bylaw by allowing

dogs to run at large and off leash in public areas was at a higher rate in the early part of Q2 but with more patrols staff have witnessed an improvement in this area. Issues with owner's failing to poop and scoop after their pets continues to be an issue in the urban areas of the Township. Enforcement Officers are patrolling daily and have issued warnings and provided education and have issued fines where applicable.

Prior to the completion of this report, the Brock Animal Shelter reported the number of dogs had increased from 1 to 10 over the July 1st long weekend and is currently operating at overcapacity starting Q3. We have managed to secure emergency assistance from foster parents and other Municipal Shelters and area Humane Societies. All shelters are starting to see the levels increase at the beginning of Q3 and the number of dogs dumped and abandoned in states of distress seem to be on the upswing in Ontario.

The By-Law Division has observed the normal increase in calls for property standards with respect to overgrown lawns and dead and decaying trees. Further increases have occurred in property standards with regard to Landlord Tenant Disputes and staff have been busy conducting internal inspections and issuing compliance orders as well as testifying at LLTTB hearings. Zoning complaints have been on the increase, primarily calls regarding permitted uses on property and an increase in persons living in trailers and RV's.

Staff are happy to report that parking infractions are down and are finding more compliance in areas where traditionally numerous problems have been present. Noise and Nuisance By-Laws are as expected on the increase but seasonal staff have been able to mitigate most of these issues through education and warnings.

This report also includes phone calls, emails, and inquiries for both bylaw and animal control related calls and the animal shelter which includes but is not limited to; staff visits to veterinarian and animal pickups, and transfers and visits by the public to the shelter for adoptions, animal claims etc.

Charts 1-4 identify the number of emails, calls, and investigations and licensing inspections for the By-Law Enforcement and Animal Services Department.

There have been no significant issues with respect to the budget as was present in the Q1 report with the Wildlife Care and Control Budget. In Q1, this was due to the outbreak of distemper in the raccoon population. In Q2, the number of calls with wildlife emergencies decreased and the number of animals entering the shelter remained low, however, the cost of veterinary care, pet food and other supplies required for the operation of the animal shelter remain at a high level. Other areas of the Departments Budget, including By-Law and Traffic control were as expected.
