# **Staff Report to the Mayor and Members of Council**

#### 1.0 Issue / Origin

The Supervisor of By-Law and Animal Services is responsible for preparing and presenting quarterly reports.

#### 2.0 Background

Council has requested in each quarter a report on the activities of the By-Law and Animal Services Department, including the Township of Brock Dench Animal Shelter. This report represents the third quarter report (Q3) from July 1<sup>st</sup>, 2024 to September 30<sup>th</sup>, 2024. The statistics for the quarterly reports include, but not limited to, emails, phone calls, and tracking software and programs used by the Department, FirePro (Bylaw) and Shelter Buddy (Animal Shelter).

#### 3.0 Analysis

In the third quarter of 2024 the Township of Brock By-Law and Animal Services Department responded to incidents/investigations in both by-law and animal services.

In Q1, Q2, and Q3, the animal shelter continued to experience a higher-than-normal volume of dogs and successfully have been able to find the majority homes throughout the summer months. Toward the end of Q3, the volume of cats and kittens has been steadily increasing but currently manageable. The number of calls for both dogs and cats found abandoned or stray has been on the decline. There have been very few calls regarding animal bites or animal interference calls.

With increased park patrols and inclusion of seasonal staff providing a consistent presence throughout the municipality, staff noted an increase in compliance of the animal control bylaw

by ensuring they kept dogs leashed in public areas, including the pickup of dog feces. Staff continue to patrol daily and have issued warnings and provided education and have issued fines where applicable.

The By-Law Division had a steady but slight increase in the volume of calls received for property standards with respect to overgrown lawns and dead and decaying trees and the Division continues to see a large increase in Landlord and Tenant disputes resulting in property inspections and dispute resolution and mediation where required. Zoning complaints stayed relatively stable in Q3.

Parking concerns and violations have stayed consistent but staff have observed a decrease in violations overall especially in areas such as the harbour and parkland. Unexpectedly, the number of noise and nuisance calls were low for the summer season and these cases were primarily handled with education and warnings from both By-law enforcement and the police.

This report also includes phone calls, emails, and inquiries for both bylaw and animal control related calls and the animal shelter which includes but is not limited to; staff visits to veterinarian and animal pickups, and transfers and visits by the public to the shelter for adoptions, animal claims, etc.

Charts 1-4 identify the number of emails, calls, and investigations and licensing inspections for the By-Law Enforcement and Animal Services Department.
