## 1.0 Issue / Origin

The primary purpose of this Policy is to ensure compliance by the Township with section 270(1) of the *Municipal Act, 2001*, as amended, which requires municipalities to adopt policies regarding the sale and other disposition of municipally owned land.

The secondary purpose is to establish a consistent, transparent and accountable procedure to be followed in the disposition of real property assets by the Township.

This policy established the procedures regarding the disposal of surplus assets and is intended to ensure that the sale or transfers of surplus assets provides:

- Efficiency, equity and transparency in transactions; and
- The best value to the taxpayer

#### 2.0 Background

The Township of Brock would like to repeal its previous by-law 1480-97-AP and bring forward a current policy to direct staff and members of Council on the sale and other disposition of municipally owned lands.

## 3.0 Analysis

The Township of Brock conducted a comprehensive review and analysis of other neighbouring municipalities policies throughout Durham Region, York Region, City of Kawartha Lakes, as well as Georgina and Ramara Townships in order to provide a thorough policy for both staff and Council.

The policy includes provisions for the declaration of surplus land, expressions of interest, obtaining surveys and appraisals, notice requirements and the methods of sale.

Currently, the Township does not have an in-depth policy but rather speaks to the sale of land through By-law 1480-97-AP. The current by-law is outdated and does not fully align with the current practises being followed by the Township. By bringing forward a new, detailed policy, it will provide staff and council with a consistent, transparent and accountable process for the sale and other disposition of municipally owned lands.
