By-Law Number 3325-2025

Being a By-law to amend By-law Number 3285-2024, being a by-law pursuant to section 391 of the Municipal Act, S.O. 2001, as amended, to impose fees for services and activities provided or done by or on behalf of the Township of Brock and for the use of municipal property.

 - 'Day Camp Registration Fee Per Week' '2025 Fee \$170.00' (HST exempt)
 - Short Week Day Camp Per Week' '2025 Fee \$135.00' (HST exempt)
 - 'Specialty Camp Per Week' '2025 Fee \$190.00' (HST exempt)
 - 'Winter/March Break Camp Daily Rate' '2025 Fee \$35.00' (HST exempt)
