Sharon Woodrow introduced her husband Don Woodrow and Reverend Jeanette Miller from Beaverton. Sharon provided a delegation with respect to 'The Witness Blanket' which included:

- this exhibit is one of two travelling replicas of The Witness Blanket and will be on display at Trinity-St.Andrew's United Church, Cannington, commencing September 7 until October 15, 2025
- the blanket is made of B.C. Redwood Cedar and measures 12 metres long, 3 metres high and weighs 2 tonnes
- the original display is exhibited at the Canadian Museum for Human Rights, Winnipeg, Manitoba
- designed as a tribute by Vancouver Island artist Carey Newman, and dedicated to his father, a survivor of the residential school system

- contains 800 items collected from schools, churches, donations, and government buildings and is interactive
- encourages others to bear witness and work towards Truth and Reconciliation
- residential school system was anti-Indigenous and genocidal
- request to Council is to promote the display, attend opening and closing ceremonies and provide any QR code readers available
