## The Corporation of the Township of Brock

## **By-Law Number 3330-2025**

Being a By-law to amend By-law Number 3285-2024, being a by-law pursuant to section 391 of the Municipal Act, S.O. 2001, as amended, to impose fees for services and activities provided or done by or on behalf of the Township of Brock and for the use of municipal property.

**Whereas** Section 391 of the Municipal Act, S.O. 2001, as amended, authorizes the Council to impose fees for services and activities provided or done by or on behalf of the Township of Brock and for the use of municipal property;

**And Whereas** Council enacted By-law Number 3285-2024, being a by-law to impose fees for services and activities provided or done by or on behalf of the Township of Brock and for the use of municipal property;

And Whereas Council deems it expedient to amend By-law Number 3285-2024;

**Now Therefore** the Council of The Corporation of the Township of Brock enacts as follows:

- 1. That Schedule "D" Parks and Recreation, Manilla & Wilfrid Town Hall Rental Rates be amended by:
  - Removing the word 'Wilfrid' from the title which shall now read as 'Manilla Town Hall Rental Rates'
- 2. That Schedule "D" Parks and Recreation, Day Camp be amended by adding:
  - 'Day Camp Registration Fee Individual Days (After June 7)', '2025 Fee Excluding HST \$38.00'
- 3. That By-law Number 3285-2024, as otherwise amended, is hereby amended to give effect to the foregoing but shall, in all other respects remain in full force and effect.
- 4. That this by-law comes into force and effect on the date of its passing and enactment.
