8. Presentations

8.1 Official Plan Review

Mr. Matt Alexander, WSP, lead consultant for the Township's Official Plan Review, provided a presentation which focused on: Purpose, Work Plan, Policy Foundations, Key Issues and Themes, and Next Steps.

Mr. Alexander noted that the Official Plan review is divided into 7 background study modules as follows:

- 1. Vision and Strategic Direction
- 2. Housing and Living Areas
- 3. Growth Management
- 4. Natural Heritage and Environmental Opportunities
- 5. Infrastructure Policy Analysis
- 6. Healthy Communities
- 7. Economic Development

Council discussed and deliberated the information provided by the consultant and provided input on the following areas:

- Public consultation and education with respect to the Official Plan review process and the requirement to conform to various Provincial policies.
- Housing types including density, affordable housing, independent senior living, and secondary dwelling units.
- 8.2 Bradford Bypass

Ministry of Transportation representatives and AECOM representatives made a presentation to Council regarding the proposed Bradford Bypass and outlined the following:

- 8.3 Report to Council on the 2020 Audit Communication No. 1031/21

Stephen Stewart, Deloitte LLP, Township appointed Auditor reviewed his report to Council regarding the 2020 audited financial statements.

Mr. Stewart advised that the financial statements were prepared in accordance with the Public Sector Accounting Standards which have not changed since last year and Deloitte conducted the audit in accordance with the Canadian Auditing Standards. He advised that Deloitte provided an unmodified audit opinion, dated June 30, 2021, on the year end financial statements dated December 31, 2020, which presented fairly in all material respects. He advised that there were no omissions or errors found, and the internal controls relevant to the financial reporting process were reviewed with no issues found. He expressed appreciation for staff's efforts with respect to the audit which was carried out remotely in a timely manner.

Mr. Stewart advised that the Township's financial position is good reminding members that the Public Sector Accounting Standards is not equivalent to Municipal Accounting Standards. He noted that the \$75 million indicated in the report as surplus includes capital assets of \$62 million which get amortized over their useful life.

Lindy and George Small: Dear Council members, we ask you to please join Barrie in passing a motion asking for a full impact assessment of the proposed by-pass (16.2 km) south of Lake Simcoe between Highways 400 and 404. The Environmental Assessment (EA) being used for the Bradford By-pass was done 24 years ago in 1997 and is out of date. A new robust EA should be conducted before any construction begins. Thank you.

15.2 Public Question/Clarification/Comment

Bill Foster: I have been advised that your Council has received a letter from Barrie Council containing a resolution concerning the harmful impacts the proposed Bradford Bypass may have on Lake Simcoe. The resolution, in accordance with the Lake Simcoe Protection Act, requests that the Government of Ontario conduct a comprehensive Impact Assessment on the potential harm the proposed Bradford Bypass may have on Lake Simcoe and identify and consider alternative routes. The resolution was copied to all Lake Simcoe Watershed Municipalities with the request that they support Barrie's resolution. I represent an association of East Gwillimbury residents who have serious concerns about the need and justification for this proposed four lane freeway (or possibly tollway). Given the number of municipalities involved, in lieu of preparing individual deputations, I have prepared a narrated PowerPoint presentation which I am sending to all municipal councillors.

Bruce Craig: As part of the Official Plan Review, will climate change and the concept of long term sustainability be given significant attention? Will there be policies which will influence design criteria requiring 'green' building standards and climate friendly approaches - pervious surface, roof design to accommodate solar panels, use of high efficiency heat pumps, etc.?
