BY-LAW NUMBER 3370-2025

A BY-LAW TO AMEND BY-LAW 3155-2022 BEING A BYLAW TO APPOINT A MEMBER OF COUNCIL TO ACT FROM TIME TO TIME IN THE PLACE OF THE HEAD OF COUNCIL

WHEREAS Section 242 of the Municipal Act, S.O. 2001, and its amendments provide that a municipality may by by-law or resolution appoint a member of the council to act in the place of the head of council when the head of council is absent or refuses to act or the office is vacant and while so acting such member has all the powers and duties of the head of council;

AND WHEREAS it is deemed expedient to appoint members to act in the place of the head of council during such absence;

NOW THEREFORE BE IN ENACTED by the Council of the Corporation of the Township of Brock as follows:

1. **THAT** Section 1 of By-law 3155-2022 be amended to read as follows:

That Ward 5 Councillor Lynn Campbell be designated Deputy Mayor to act in the place of the head of Council due to absence or refusal to act or the office is vacant.

2. **THAT** Section 2 of By-law 3155-2022 be amended to read as follows:

That the following members of council be designated to act in the absence of the head of Council and the absence of the Deputy Mayor due to absence or refusal to act or the office is vacant as required for the periods noted:
