

Purpose of this Meeting

Under Section 26(3)(b) of the *Planning Act*, before making revisions to the Official Plan, the Municipality is required to hold a Special Meeting of Council, open to the public, to discuss potential revisions.

The purpose of this Special Meeting of Council is to discuss potential updates to the Official Plan and to provide an opportunity for the public provide input on issues or matters that should be considered in the Official Plan Review.

Official Plan Review Purpose

The current Official Plan was adopted in 2006 and last consolidated in 2018 (Planning Act requires review/update every 5 years).

This review will focus on updates to reflect more recent legislation and policy, including:

- Recent amendments to the Planning Act;
- Provincial Policy Statement, 2020;
- Durham Region Official Plan, year, and the Municipal Comprehensive Review currently underway;
- Recent studies/strategies from the Municipality, the Region, and Conservation Authorities; and
- Changes to the local context

The Official Plan Review is divided into 7 background study modules to help focus research and discussion of key issues

- Vision and Strategic Direction (April, 2021 to August, 2021)
- 2. Housing and Living Areas (April, 2021 to October, 2021)
- 3. Growth Management (July, 2021 to December, 2021)
- Natural Heritage and Environmental Opportunities
 (October, 2021 to April, 2022)
- Infrastructure Policy Analysis (November, 2021 to April, 2022)
- Healthy Communities (April, 2022 to October, 2022)
- Economic Development (July, 2022 to December, 2022)

- Public Engagement Activities
- · Background Research
 - Including Review of existing polices
- Preparation of a Discussion Paper
- Presentation to Council
