THE CORPORATION OF THE TOWNSHIP OF BROCK

BY-LAW NUMBER 3096-2022

A BY-LAW TO AMEND BY-LAW NUMBER 3017-2021, BEING A BY-LAW TO REGULATE THE PROCEEDINGS OF COUNCIL

WHEREAS Section 238(2) of the *Municipal Act* requires every Council to adopt a procedure bylaw for governing the calling, place and proceedings of meetings;

AND WHEREAS the Council of the Township of Brock enacted By-law Number 3017-2021 on the 4th day of March 2021, to regulate the proceedings of Council

AND WHEREAS the Council of the Corporation of the Township of Brock deems is expedient to undertake certain amendments to By-law Number 3017-2021;

NOW THEREFORE the Council of the Corporation of the Township of Brock enacts as follows:

- 1. That Section 1.1.11 be amended to read "Committee of the Whole" means a committee comprised of all Members of Council that serves as the principle forum for the consideration of recommendations to Council on all administrative and general governance matters affecting the Township".
- 2. That Section 1.1.12 be amended to read "Consent Agenda" means a single motion to adopt all items or any group of items on an agenda. Should a member wish to discuss an item, they would request the item be extracted from the consent agenda and that item would be discussed separately.
- **3.** That Section 1.1.22 be amended to read "Petition" means a formal written request signed by two or more people appealing to Council with respect to a particular matter.
- **4.** That Section 1.1.23 "Planning and Community Affairs" be deleted in its entirety, and the following sections be renumbered accordingly.
- **5.** That Section 1.1.29 be amended to read "Standing Committee" means a means a Committee appointed by and directly reporting to Council, created from time to time, and currently comprised of the following Committee: Committee of the Whole
- **6.** That Section 3.3 be amended to read "The Mayor shall Chair all Council and COW meetings and when absent, the Deputy Mayor shall Chair. In the absence of the Mayor and Deputy Mayor, the Acting Mayor shall Chair"
- 7. That Section 3.4 be amended to read "Council shall establish a COW which shall be comprised of all Members of Council and which shall make recommendations to Council. Council may consider any matter without referring it to the COW
- **8.** That Section 3.5 be deleted in its entirety, and the following sections renumbered accordingly.

- 9. That Section 3.6 be amended to read "Selected Members of Council may be appointed as a Sub-Committee Chair by Resolution during the Inaugural Meeting of Council or when a vacancy in his or her absence occurs as determined by Council from time to time or upon resolution by Council at any time during the term of Council. The Sub-Committee Chair or when absent, the Mayor, shall take the chair during that portion of the COW Meeting dealing with the matters pertaining to the Sub-Committee for which he or she has been appointed."
- **10.** That Section 3.6 a) Sub Committees be amended by inserting "Building and Planning Committee" following Protection Services
- **11.** That Section 3.7 be amended to read "The COW may consider delegations, presentations and staff reports, as set out in Schedule A to this by-law."
- **12.** That Section 3.8 be amended to read "Council shall be mandated with holding public meetings and any other planning and development matter or matter deemed to require public consultation"
- **13.** That Section 3.11 be deleted in its entirety and the following sections renumbered accordingly.
- **14.** That Section 4.1.1 be amended to read "The Inaugural Meeting of Council shall be held at any time following the start of the new term of Council, but no later then 31 days after the term commences."
- **15.** That Section 4.2 be renamed Council and COW Regular Meetings
- **16.** That Section 4.2.1 be amended to read "All regular meetings shall be held in the Council Chambers at the Municipal Administration Building, 1 Cameron Street East, Cannington, Ontario, or electronically or a combination of both, and in accordance with the meeting schedule as approved by Council."
- **17.** That Section 4.2.2 be amended to read "The regular meeting schedule shall be based as follows, with adjustments made for public holidays and municipal conferences usually attended by Council and staff:
 - a) COW meeting on the 2nd Monday of the month, with the open session starting at 10:00 a.m.
 - b) COW meeting on the 4th Monday of the month with the open session starting at 1:30 p.m.
 - c) Council meeting on the 4th Monday of the month, with open session starting at 6:00 p.m.
 - d) Workshop meetings will be held quarterly as required, and open to the public starting at 10:00 a.m.
- **18.** That Section 4.6.2 be deleted in its entirety and the following sections be renumbered accordingly.
- **19.** That Section 4.8.1 be amended to read "A quorum of Council and COW shall be a majority of members present."

- **25.** That Section 8.5.2 be amended to read: Anyone wishing to appear before COW or Council must complete the required form on the website, and submit it to the Clerk's office by 12:30 p.m. on the Tuesday prior to the meeting stating in detail the nature of the matter to be presented."
- **26.** That Section 8.6.1 be amended to read: "An organizer of a public petition may submit a petition for inclusion on a Council agenda. That person shall provide their name and contact information (address and email address) along with the petition. Any communication with respect to the petition will be with the organizer of the petition only."

- **32.** That Section 8.10.1 be amended to read: "A member desiring to introduce a subject for discussion or consideration by Council shall provide Notice of Motion, in writing on the form as provided by the Clerk, with a confirmed mover and seconder, to the Clerk, by no later than 12:30 p.m. on the Tuesday prior to the regular Council meeting."
- **33.** That Sections 8.14 and 8.15 be deleted in their entirety and the following sections renumbered accordingly.
- **34.** That "Provision for Consent Agenda

 More than one agenda item containing recommendations on a Meeting agenda may be adopted in a single motion. A Member may request that any specific agenda item be subject to individual consideration. The provision for consent agenda and adopting

recommendations in a single motion may be utilized at any point in a meeting agenda." Be inserted following Section 9.6.9 Recorded Vote
