1.0 Issue / Origin

2.0 Background

The 2022 Capital Budget included \$200,000 for completing Double Surface Treatment and \$360,000 for completing Slurry Seal on various in the Township of Brock. The tender for this contract was prepared by staff and distributed to sixteen (16) contractors and posted on the municipal website. The closing date of the tender was 2:00 pm., Tuesday, April 19, 2022. The Director of Public Works and Public Works Coordinator and Treasurer opened the tenders shortly after the closing date/time.

3.0 Analysis

The tender results are itemized in the table below;

The amounts outlined in the above noted summary are the combined prices for both Double Surface Treatment and Slurry Seal.

The tenders were reviewed by the Director of Public Works and were found to generally satisfy the requirements set out in the tender documents. The bid provided by Duncor Enterprises Inc. was the low bid and was determined to meet the tender requirements.

5.0 Financial / Budget Assessment

The 2022 Capital Budget includes \$200,000 for completing Double Surface Treatment and \$360,000 for completing Slurry Seal on various roads in the Township of Brock. Based on the tender price being lower than the amount budgeted, staff will monitor the work closely and determine if additional locations can be included in the contract.
