1.0 Issue / Origin

2.0 Background

The 2022 Capital Budget included \$350,000 for completing HL-2 Ultrathin Resurfacing on various streets in the Township of Brock. The tender for this contract was prepared by staff and distributed to sixteen (16) contractors and posted on the municipal website. The closing date of the tender was 2:00 pm Thursday, April 14th, 2022. The Director of Public Works and the Public Works Coordinator and the Treasurer opened the tenders shortly after the closing date/time.

3.0 Analysis

The tender results are itemized in the table below:

The tenders were reviewed by the Director of Public Works and were found to generally satisfy the requirements set out in the tender documents. The bid provided by Ashland Construction Group Ltd. was the low bid and was determined to meet the tender requirements.

The 2022 Capital Budget includes \$350,000 for HL-2 Ultrathin Resurfacing.
