### **AMO-COU Lecture: Adapting to Climate Change: Local Government Tools to Build Climate Resilience**

Dr. Daniel Henstra is a Professor of Political Science at the University of Waterloo and Co-Lead of the Climate Risk Research Group where he works with government and business organizations to develop practical, evidence-based policy solutions to climate-related challenges. Dr. Henstra has a remarkable record of research and collaboration with government at all levels and will provide concrete examples of work municipalities have undertaken to address the impacts of climate change.

### **Fostering collaboration and cooperation to search for solutions to the Opioid crisis, sponsored by Emergent**

The Opioid Crisis in our communities: Since the introduction of the naloxone ready community at our AMO General Meeting in 2019, we have seen the COVID-19 pandemic exacerbated an already dire situation and made it worse. Municipalities across Ontario are facing increased demands as they work to address the ongoing Public Health crisis, with multiple agencies and partners working towards common goals, but often with limited integration of efforts. Understanding the need to foster collaboration and cooperation, as a way to streamline efforts as resources and people become limited, we are excited to present the Overdose and Prevention Engagement Network (OPEN), a platform founded on the objective of bringing together people to share best practices, adapt existing ones and continue to search for solutions.

### **OMERS Update**

With \$121 billion in assets as of 2021, OMERS is one of the largest pension funds in Ontario. AMO's member municipal governments are OMERS' largest employer group, representing more than 36% of active Plan members in 2021.
