By-Law Number 3150-2022

A By-Law to Amend Brock Traffic Control Bylaw 957-88-PP, as Amended,

WHEREAS Section 8 of the *Municipal Act, 2001, S.O. 2001, Chap. 25, as amended*, authorizes municipalities to enact by- laws regulating or prohibiting matters such as parking; and

WHEREAS pursuant to the provisions of the *Municipal Act, 2001, S.O. 2001, Chap. 25, as amended*, and the provisions of the *Highway Traffic Act, R.S.O 1990, Chap. H.8, as amended*, by-laws may be passed by the councils of local municipalities to control traffic; and

WHEREAS Council of the Corporation of the Township of Brock previously enacted By-Law Number 957-88-PP, as amended, known as the Traffic Control By-Law; and

WHEREAS Council desires to further amend By-Law Number 957-88-PP, as amended, to approve an overnight winter parking ban between November 15th and April 15th; and

WHEREAS Council desires to further amend By-Law Number 957-88-PP, as amended, to allow for a limited number of paid parking spaces within Municipal Lots in Sunderland; and

WHEREAS Council desires to further amend By-Law Number 957-88-PP, as amended, to allow for grammatical changes and current legislation.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Brock hereby enacts as follows:

1. THAT Section 2.35 of By-law 957-88-PP, as amended, be repealed in its entirety, and replaced with the following:

2.35 **Roadway** shall also mean a Highway.

- 2. THAT Section 9.1 of By-law 957-88-PP, as amended, be repealed in its entirety, and replaced with the following:
 - 9.1 No Person shall on any highway park any vehicle:
 - (a) In front of or within 1 m of a driveway or private roadway.
 - (b) Within 3 m of any fire hydrant.
 - (c) Within 10 m of an intersecting roadway that is not controlled by a signal light traffic control system.
 - (d) For the purpose of displaying the vehicle for sale.
 - (e) For the purpose of washing, greasing or repairing the vehicle.

- (f) Within 4 m of the tracks of any railway other than a street railway.
- (g) Within 15 m of the nearest rail of a level railway crossing.
- (h) In such a position as will prevent the removal of any other vehicle previously parked.
- (i) For a period in excess of three (3) hours unless otherwise indicated by official signs or by paid permitted parking as outlined in Section 9.3 and Section 9.6.
- (j) On or over any boulevard or sidewalk.
- (k) On the travelled portion of a roadway other than a cul-de-sac where the roadway within is 6 m or less.
- (I) Within 15 m of an intersection controlled by a signal light traffic control system.
- (m) On or within 100 m of a bridge over, under, or across which a highway passes.
- (n) On any curved portion of a roadway, where signed accordingly.
- (o) On either side of a highway within 30 m of a fire hall.
- (p) Within 15 m of the end of a roadway on a dead-end highway.
- 3. THAT Section 9.2 of By-law 957-88-PP, as amended, be repealed in its entirety, and replaced with the following:
 - 9.2 Where official signs to that effect are displayed, no person shall on any highway park any vehicle:
 - (a) On either side of a highway within 30 m of a fire hall.
 - (b) Anytime on one or both sides of a highway or portion of a highway which is immediately adjacent to a park or playground.
 - (c) Within 15 m of the end of a roadway on a dead-end highway.
- 4. THAT Section 9.3 of By-law 957-88-PP, as amended, be repealed in its entirety, and replaced with the following:
 - 9.3 Parking on Municipal Property

Where official or authorized signs to that effect are displayed, no person shall park or leave any vehicle on municipal property.

(a) Parking on Municipal Property - Parking Permits

Notwithstanding Section 9.1 (i) and Section 9.3, the Municipal Clerk and/or Council is hereby authorized to establish procedures for the issuance of daily, monthly, seasonal or annual parking permits in dedicated municipal parking lots or berthing areas, as shown on Schedule XX, upon the completion of a required form and payment of the prescribed fee as outlined in the Fees and Charges By-law.

- 4. THAT Section 9.6 of By-law 957-88-PP, as amended, be repealed in its entirety, and replaced with the following:
 - 9.6 Parking on Municipal Roadways

Notwithstanding Section 9.1 (i) and Section 9.6, the Municipal Clerk and/or Council is hereby authorized to establish procedures for the issuance of parking permits on municipal roadways between April 15th and November 15th in a calendar year upon the completion of a required form and payment of the prescribed fee as outlined in the Fees and Charges By-law.

- 5. THAT By-law 957-88-PP, as amended, be further amended to include a new Section 9.7 to read as follows:
 - 9.7 Winter Parking Restrictions
 - (a) No person shall park a vehicle on a highway at any time between 12:00 a.m. to 7:00 a.m. between November 15th to April 15th, inclusive of those dates.
 - (b) Notwithstanding any restrictions within this by-law, the Township of Brock Director of Public Works, or their designate, is authorized to enact a "Winter Weather Parking Ban" in accordance to the Municipal Act, as amended.
- 6. THAT a new Schedule XX be included to from part of By-law 957-88-PP, as amended, identifying permitted parking in selected municipal properties or berthing rights be
