4.1 Explanatory Note - B1845 Regional Rd 15, Beaverton - 13-2022-RA Wechsel

The purpose of this Statutory Public meeting, pursuant to the Planning Act R.S.O. 1990, was to inform the public of the details of an application to amend Zoning By-law 287-78-PL for the rezoning of lands at B1845 Regional Road 15, Beaverton, to recognize the existing dwelling as a rural residential lot to facilitate the severance of a surplus farm dwelling and to rezone the retained farmland so that no further severances or residential uses are permitted. The retained farmland will continue to be farmed as part of a larger farm operation. This meeting provided an opportunity for public comments on the proposed amendment. Members of Council were in attendance to observe and listen to comments.

4.2 Staff Presentation/Overview

The Director of Development Services provided a presentation which included the following:

- proposed zoning by-law amendment would rezone the property from Rural (RU) and Environmental Protection (EP) to Rural Residential (RR), site specific Rural Exception (RU-XX), and site specific Environmental Protection Exception (EP-XX)
- application is to sever off the existing house from the farmland
- planning processes at the Provincial, Regional, and municipal level
- the application is being concurrently processed at the Region of Durham

- located on the north side of Regional Road 15 west of Thorah Sideroad
- zoned prime agricultural land with permitted uses being agricultural and single detached dwelling
- notice of this meeting was properly circulated
