BY-LAW ENFORCEMENT AND ANIMAL SERVICES YEAR END REPORT 2022



WHO WE ARE

FT Supervisor, 1 FT By-Law Officer (SR), 1 FT Animal Control Officer, 3 Pt By-Law/Animal Control Officers, 2 Seasonal By-Law Officers (May-Sept) and 8 School Crossing Guards. All By-Law/Animal Control Officers are cross trained to administer all enforcement duties.

Administration Division: Comprised of the The By-Law Enforcement and Animal Control Supervisor, and responsible for the overall operation and administration of the Department which includes but is not limited to, By-Law, Animal Control, Parking, Licensing, Property Standards, Dench Animal Shelter and the Crossing Guard Program. The FT By-Law Officer and FT Animal Services Officer assist the Supervisor in basic administrative and operational needs, including annual training program and parking administration.

Both FT and PT staff conduct the following duties, along with the Supervisor for the following services:



BY-LAW ENFORCEMENT

The By-law Enforcement and Animal Services Department ensures Township residents and visitors adhere to the Township by-laws related to public property offences, excessive loud music, at large animals, animal bite investigations, property standards and parking infractions. This Department is committed to maintain the safety of the public as they use roads, sidewalks, parks and other common public spaces. Officers provide public education, awareness programs and services to residents, businesses, and property owners.

Municipal By-law Complaints

Officers are responsible for enforcing City by-laws and make every effort to resolve the complaints through voluntary compliance. Municipal complaint investigations are more complex and require an officer to spend more time investigating, to come to a successful resolution.



BY-LAW ENFORCEMENT (Cont.)

Parking Enforcement

Parking enforcement is a primary part of enforcement. The Department received 24 parking-related complaints in 2022. Parking patrol operations resulted in **413** parking infraction notices issued. This is almost double the amount of infractions issued the previous year.





In 2022 amendments to the Traffic Control By-Law included the introduction of winter restrictions for overnight parking. Starting November 15th through to April 15th, no overnight on-street parking and parking in a Municipal Lots (unless permitted) will be permitted between the hours of 12:00 a.m. and 7:00 a.m., regardless of weather conditions, to allow for thorough and efficient winter maintenance operations. To enforce these new restrictions, By-Law deploys and officer 2 to 3 times a week for overnight parking enforcement. From the implementation of the amendments, enforcement officers issued 85 parking infractions related to winter parking restrictions from November 15th to December 31st, 2022.

PROPERTY STANDARDS

One of the roles of By-Law Officers is to enforce by-laws that prescribe minimum standards for the maintenance and occupancy of properties, and their permitted uses. These by-laws require properties that do not conform to these specifications be repaired and maintained.

Brock By-Law Officers received 78 calls for investigation or mediation in 2022. 66 where resolved with order compliance or officer mediation. 12 investigations resulted in property maintenance remedy provided by the Township of Brock, at the owners expense due to non-compliance of an order. 3 Properties still remain outstanding from 2022. 1 property/owner has appealed an order to the superior court and is on hold for remedy until a court decision has been made.

There were two appeals heard by the Property Standards Committee and the decision in both appeals was to uphold the orders issued by By-Law Staff to remedy the property.



LICENSING ENFORCEMENT

By-Law Officers or Municipal Licensing Enforcement Officers monitor, investigate and enforce the licensing of mobile and stationary businesses. Licensing is essential in the promotion of the protection of consumers and supports the health and safety of the public.
